

Local Law Review Engagement Summary (Phase 1: 20 January to 20 March 2023)

Introduction

The Local Law is reviewed every 10 years and we are now preparing to revise these laws in a new Community Local Law friendly format so they can capture current key issues and so they can commence in July 2024. The Local Law covers a range of diverse topics. From unsightly land, fire safety, animals, roadside reserves and footpath trading to planting on nature strips and building sites. Local laws are designed to enhance community safety, protect property and help make our neighbourhoods and living in the City of Whittlesea 'A Place for All'.

Between 20 January – 20 March 2023, The City of Whittlesea conducted an eight-week community engagement program to gather community and stakeholder feedback on nine key proposed Local Law ideas as well as feedback on the existing Local Law. Council undertook community consultation with people who live, work, study or visit the City of Whittlesea to understand community issues and needs across the municipality. The feedback received will be used to review and update the City of Whittlesea's Local Law to ensure they are both enforceable and reflect local needs.

How we engaged you

The initial community engagement was open for community comment from 20 January – 20 March 2023.

Community feedback was sought online through Council's Engage Whittlesea platform and through direct conversation and activities at community pop-ups and meetings with key stakeholders.

The project Engage page featured nine key proposed local law ideas and invited the community to provide feedback on how important the ideas are, whether they support the ideas, and any offered an opportunity for them to provide further comments.

The project team hosted 22 community pop-ups in high foot traffic locations across the municipality. At the pop-ups, participants were introduced to nine key proposed local law ideas and asked if they would support them by voting yes, they support the idea or no they don't support the idea. Through conversation with the project team participants were given the opportunity to provide further comment.

The community pop-ups held were:

To ensure language wasn't a barrier to participation the digital engagement could be translated into the top ten languages spoken within the municipality through the translation function on the site. The project team, supported by bilingual aides also held targeted pop-ups at key CALD community group meetings and events. These groups were identified as the ones with the lowest level of proficiency in English and the least likely to be able to access the digital consultation or spoke a language the page wasn't translated into. The CALD community pop-ups held were:

The community engagement was promoted utilising a wide range of tactics including:

- Postcards distributed at community-based pop-ups
- Notification to members of the Engage Whittlesea platform
- Social media we shared posts across Council's channels (Facebook, LinkedIn and Twitter)
- Email to key stakeholder groups including the Business Advisory Panel, Youth Advisory Committee, Sporting Clubs and key not for profit organisations
- Signage at key locations related to the nine key proposal local law ideas including Epping Animal Welfare Shelter, pet stores, veterinary clinics, sporting grounds etc.
- Meetings with key internal stakeholders
- Internal Local Law Review staff engagement session



Participation

A total of 1707 people participated in the community engagement. This included 590 online surveys, 1106 participants at community pop-up events and 11 detailed emails.

The table below summarises the number of votes from community in relation to each proposed local law idea and breaks down the number of adults and under 18-year old's who participated.

Five of the of the proposed local law ideas scored over 90% support, three had over 80% support and one had over 70% support.

Digital engagement Engage Page

Respondents were presented with the nine key issues that have proposed local law ideas. Participants were given the opportunity to rate how big each issue was, choose how appropriate they felt the current local law for each issue was and finally if they supported the proposed ideas or changes to the local law.











Issue Rating

The nine issues are presented below in order of how big each issue was overall. Respondents were asked to rate each issue from 1 (not a big issue) to 5 (really big issue). *Dumping of hard rubbish* was the highest rating with most people rating it 3 or above as a 'big' to 'really big' issue. *Allowing recreational use of fire pits* was not seen as a big issue to most respondents.





Issue rating captured through digital consultation

Appropriateness of current local law

Community was asked how appropriate the current local law was for each of the nine issues. The below graph outlines the results. Majority of respondents feel that stronger local laws are needed across eight of the nine issues. In response to the issue of "allowing recreational use of firepits", most respondents felt that fewer or no local laws were needed.

Support of proposed changes

Respondents shared if they supported the proposed change. More than 50% of respondents supported the proposed changes to all the nine issues. The highest level of support was for broadening the smoking definition to include vapes and e-cigarettes. With the lowest level of support being for nature strip maintenance changes.

Comments of what we heard

114 respondents gave further comments on the issue of 'Broaden definition of smoking to include vapes and e-cigarettes'



"Smoking of any kind should not be permitted within 100m of any shopping strips, park, oval, school, childcare, or council building."

"More control over minors who are vaping, as well as better education through the schools."

"This should be a state or national priority too"

"Vapes are getting out of control amongst children and something needs to be done to ban them."

140 respondents gave further comments on the issue of "Allowing recreational use of firepits"



"Allowing recreational use should be allowed as long as residents are using them responsibly and with the right materials to not cause a nuisance to their neighbours"

"Recreational use only. Not for burning off"

"Educate the use of Firepits, suitable wood, location in backyard (what to avoid), taking the weather into consideration (strong winds that may force the fire/smoke across to neighbouring properties) - Perhaps provide council leaflets with the sale of Firepits from local suppliers."

263 respondents gave further comments on the issue of "Nature strip maintenance"



"Environmentally friendly nature strip's please"



"Maximum height, and free from rubbish should be enforced, however I think there should be a warning and time given to fix problem before fines are sent"

"The council should maintain the strips in streets that are not privately owned. Council needs to lead by example"

181 respondents gave further comments on the issue of "long-term parking and/or storage of trailers, caravans and boats"



"I have almost hit a passing car whilst backing out of my driveway due to a boat and caravan parked on the road. It's dangerous for the kids playing in the street and riding their bikes and scooters. Plus, it restricts visitor car parking."

"We need more facilities for boat, trailer and caravan storage. House blocks and new housing developments are getting smaller along with residential roads getting narrower and yet councils still don't provide adequate storage facilities within their council area."

239 respondents gave further comments on the issue of "Dumping of hard rubbish and second-hand goods on nature strips"



"Massive issue in the area. Hard rubbish dumped everywhere we go. Council should implement harsher fines. Hand out instructions on how to book hard rubbish collection because there are a lot of migrants in the area that might genuinely not know about this service offered by the council."

"We need more hard rubbish to be collected"

"This can be a great way to reuse and recycle items. I do also agree that there needs to be regulation on how long the items are to be left on the nature strip."

80 respondents gave further comments on the issue of "Prevention of derelict and dilapidated buildings"





"If these buildings are occupied the people should be supported."

"This is a great proposal. Sick of developers purposefully allowing properties to become derelict so that they have justification to remove them. Please implement this and have much higher fines / consequences for land developers"

"Becoming a major issue here in Mernda/Schotters Road with multiple houses derelict for an extended period, graffitied, vandalised and attracting squatters."

124 respondents gave additional comments on the issue of "Dumping and abandonment of shopping trolleys."



"Not all mechanisms introduced such as brakes and coins work. Retailers need to promote returning them and fine people that take them."

"Easy way to report to organize collection"

"Coin operated trolleys and trolleys with locking wheels can be difficult or dangerous for people with disabilities and the elderly - those who need them most. Require shops to collect them, but don't make shopping less safe for people."

139 respondents gave additional comments on the issue of "Dog attack laws".



"Dogs should not be allowed in parks or on common roads unless they are leashed."

"Within means, it's also the responsibility of the individual not to provoke or pat dogs over someone's fence/gate"

"I agree that no animal/pet should attack another animal or person however, I believe that each situation needs to assessed individually."



166 respondents gave additional comments on the issue of "Managing dogs on sporting grounds".




"I believe if there is nobody else using a grass oval then allowing a dog on the oval would be fine provided the owner cleans up after it. Dogs should not be allowed on a synthetic grass oval at all."

"I do feel that council needs to have more bins for disposing of dog waste. As a dog owner who often goes on walks around my home in South Morang, I see too much dog waste not picked up which really disgusts me."

"Provide poop bags and bins with signage about rules."

Overall support of proposed changes

The common question asked at both in person and online consultation was "Do you support the proposed ideas/changes for each issue?" The below graph shows that over 70% of respondents supported all of the proposed ideas. The proposed changes to the idea of "Broadening the definition of smoking to include vapes and e-cigarettes" was the highest with over 90% of respondents supporting. "Enforcement of the collection of dumped or abandoned shopping trolleys" was the least supported with 73.6% of people supporting the change and 23% not supporting.

Additional topics/issues and feedback received

As part of the online survey and in person pop-up sessions, participants were invited to provide responses to new ideas and any other additional topics and issues for consideration.

The content of the feedback received was reviewed and the sentiment assessed. Majority of the feedback related to community safety concerns and amenity rather than to the Local Laws, including:

- Increased surveillance around parks and walking tracks, addressing safety and dogs off leash
- Better street lighting at night
- Insufficient off-street parking in residential areas
- Trees on private property (leaf litter, nuisance from fruit and gum trees)
- Increased waste collection options (biannual, or annual hard rubbish collection, collaborating with charities and establishing regular hard rubbish drop off points)
- Address amenity-related pollution (lighting, noise and/or fume)
- More resident consultation about trees (appropriate types of trees)
- Council to better maintain parks and grasslands
- Increasing the number of dog off-leash parks, supporting banning dogs on sporting ground if other options are available
- Not enough or no truck parking areas/depots in the municipality, some feedback included further options for caravan storage.

Feedback that related to the review of current and new Local Laws included:

- Review of permitted street trading activities
- Review of permitted sex-work activities
- Smoke caused from open-air burning and woodfire heaters
- Introduction of hooning laws
- Increase signage around sporting areas related to animal behaviour specifically sporting grounds should not become off-leash areas and dogs must be on a leash in all public places
- Increase signage relating to smoking around Council buildings
- Illegally parked cars on footpaths and nature strips
- Limit the movement and parking of large trucks and commercial vehicles in residential streets (some feedback included banning trucks)
- Stricter guidelines for building sites regarding maintaining crossovers and clean, safe public walkways
- Increased regulation of fencing / confinement of dogs and other animals
- Fire management and better control over developers

Issues considered 'out-of-scope' for the Local Law Review included any animal-related actions from the Domestic Animal Management Plan, policies, guidelines and permits and the setting of fines, fees and charges as well as the application and enforcement of the Law.



Next steps

Feedback gathered from the community is being used to create a draft Community Local Law and has fed into the development of other related plans and strategies including the draft Nature strip Guidelines.
